RESOLUTION APPROVING ANNEXATION OF TERRITORY
TO the City of Ukiah

Designated as, Ukiah Unified School District
Low Gap Property Annexation

The following resolution is now offered and read:

WHEREAS, a petition for annexation of territory to City of Ukiah
_____ was duly filed with the Mendocino County Local
Agency Formation Commission, together with supporting documents required by
the rules of said Commission on August 20, 1975;
and

WHEREAS, said petition has been processed pursuant to the provisions
of Chapter 6.6 of Part 1, Division 2, Title 5 of the Government Code of
the State of California; and

WHEREAS, at the times and in the form and manner provided by law, said
Executive Officer has given notice of public hearing by this Commission upon
said petition; and

WHEREAS, said Executive Officer has reviewed said petition and prepared
a report, including his recommendations thereon, said petition and report
having been presented to and considered by this Commission;
and

WHEREAS, the public hearing by this Commission was held upon the
date and at the time and place specified in said Notice of Public Hearing
and in any subsequent hearings; and

WHEREAS, at such hearing this Commission heard and received all
oral and written protests, objections and evidence which were made, presented,
or filed, and all persons present were given the opportunity to hear and be
heard in respect to any matter relating to said petition and report.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED that the annexation of
territory to the City of Ukiah being identified in

the files of the Mendocino County Local Agency Formation Commission as
File No. 75-10, designated as Ukiah Unified School District Low Gap Property
Annexation to the City of Ukiah
be and the same is hereby approved by the Mendocino
(approved/denied)
County Local Agency Formation Commission, subject to the following
conditions and terms:

1. Amend map to exclude from annexation that strip of land as described in the document presented by the Ukiah Unified School District.
2. Ukiah Unified School District offer for dedication to the county that strip of land which has been excluded by above
3. Area to be withdrawn from Ukiah Valley Fire Protection District
4. Area to be withdrawn from Millview County Water District.

BE IT FURTHER RESOLVED AND ORDERED that the Executive Officer of
said Commission is hereby authorized and directed to mail certified copies
of this resolution in the manner as provided by law.
