WHEREAS, a proposal for the proposed annexation of certain territory to the Anderson Valley Cemetery District has been filed with the Executive Officer of this Local Agency Formation Commission pursuant to Title 5, Division 3, commencing with Section 56000 of the Government Code; and ,

WHEREAS, the Executive Officer has reviewed the proposal and prepared a report, including his recommendation thereon, the proposal and report having been presented to, and considered by this Commission; and,

WHEREAS, it has been determined to the satisfaction of this Commission that all owners of land included in the proposal consent to this annexation; and,

WHEREAS, this Commission called for and held a public hearing on the proposal on Feb. 2, 87 and at the hearing this Commission heard and received all oral and written protests, all persons present were given an opportunity to hear and be heard with respect to this proposal and the report of the Executive Officer.

NOW, THEREFORE, the Mendocino Local Agency Formation Commission DOES HEREBY RESOLVE, DETERMINE AND ORDER AS FOLLOWS:

- 1. That the proposal is categorically exempt pursuant to Section 15301 of State Guidelines, Class 1, in that this involves negligible expansion of use beyond what has previously been cemetery expansion area.
- 2. The proposal is hereby approved/denied subject to the conditions and terms being identified in Exhibit A.

- 2. The boundaries, as set forth in the proposal, are hereby approved as submitted, in compliance with the conditions set forth in Exhibit "A" and will be incorporated as Exhibit "B" herein when completed by the <code>City-of-Anderson Valley Cemetery</code>.District
- 3. The territory includes 150 miles 150 miles, is found to be uninhabited/inhabited, and is assigned the following distinctive short form designation: Yorkville Annexation to the £ixyxxxx Anderson Valley Cemetery

- 4. The &**** District is designated as the conducting authority and the City_Council_of_the_City_of District is hereby authorized to conduct subsequent proceedings in compliance with this resolution.
