4. Frank McMichael, District Manager - Ukiah Valley Sanitation District, spoke in regards to possible Brown Act violations in the noticing of the June 1, 2015 Regular Commission Meeting, and Public Hearings for the FY 2015-16 Budget on May 4, 2015 and June 1, 2015.

Public Hearing

5. Final Fiscal Year 2015-16 Mendocino LAFCo Budget

Vice Chair McCowen asked the Executive Officer to address the procedural questions raised during Public Expression before opening the Public Hearing.

Comments and questions were offered by Commissioner McNerlin, Hammerstrom, Madrigal, Silver, Ward, Brown, Hamburg, and Rosenberg, George Williamson, Frank McMichael, and Lee Howard.

George Williamson responded to the procedural questions, distributing and presenting a FY 2015-16 Budget Preparation and Review Chronology he prepared. He noted a letter from the Law Offices of John E. Sharp on behalf of the Ukiah Valley Sanitation District regarding Failure of Mendocino County Local Agency Formation Commission to Provide Proper Notice for Proposed Budget was received Friday afternoon, May 29, 2015 which was attached to the Chronology.

Vice Chair McCowen noted the Commissioners had not received copy or notice of this letter until today's meeting.

George Williamson stated that LAFCo Legal Counsel has advised that when Legal Counsel is copied in correspondence to LAFCo, as this letter was, it becomes privileged communications and Mr. Williamson therefore immediately attempted to contact Scott Browne and was unable to reach him before the meeting.

Commissioner McNerlin noted concern over the lack of Public Hearing Notice to the Special Districts, Cities and County for the May 4, 2015 FY 2015-16 Budget. Vice Chair McCowen noted concern as to whether the points raised were true or not true, and the implications for each point raised if they are true. GW spoke to each point, noting supporting law where appropriate.

Frank McMichael spoke in regards to the website posting requirements and past noticing practice of LAFCo. He also noted the Ukiah Valley Sanitation District has issue with Line 24 of the Proposed Approved FY 2015-16 Budget "Special District Training Support."

Lee Howard, "speaking as Lee Howard and only Lee Howard" spoke in regards to possible Brown Act violations in the noticing.

George Williamson recommended the Commission open the Public Hearing and continue it to a date certain, in order to allow time for 21 day noticing to Special Districts, Cities, County and general public, as well as conference with the Legal Counsel.

WHEREAS, questions have been raised as to the timeliness of notice of LAFCo budget actions and the Commission desires to extend the Budget Hearing process to renotice the final budget hearing with the required 21 days notice; and

WHEREAS, the Commission is required to adopt a budget by June 15th and therefore to comply with that requirement it adopted an Interim Final Budget on June 8th to be in effect until the Final Budget is adopted and set a hearing for adoption of the Final Budget for its regular meeting of July 13, 2015.

WHEREAS, thereafter notice of hearing on the final budget was duly given 21 days prior to hearing and a public hearing held with regard to adoption of the Final Budget on July 13th and the public testimony on the Budget considered by the Commission.

NOW, THEREFORE, the Mendocino Local Agency Formation Commission does hereby RESOLVE, DETERMINE, and ORDER as follows:

1. In accordance with Government Code Section 56381(a), the Commission hereby adopts the Final Budget for the 2015-16 Fiscal Year with anticipated revenues in the amount of \$159,028; and proposed expenditures in the amount of \$184,528.

- 2. Details of the Budget are specified by line item in the budget document, attached hereto as Exhibit A.
- 3. The Budget reflects that the Commission has determined to draw down agency reserves and carry-over funds to reduce contributions from member agencies for this fiscal year. Accordingly, the member agency contributions shall be reduced from the prior Fiscal Year t, with the County of Mendocino contributing \$41,666; the four cities contributing \$41,666; and the 50 Independent Special Districts contributing \$41,666. Member agencies will be advised that such a reduction is only feasible for this fiscal year and that the contribution amounts are likely to be increased in future years.
- 4. The Final Budget is reduced from the prior year budget, The Commission finds, as required by §56381 that the reduced program costs will nevertheless allow the Commission to fulfill its required duties under the Cortese Knox Hertzberg Act and will allow the Commission to operate on a day-to-day basis; will provide necessary services to all local government agencies; and will insure that adequate progress is made on the Municipal Service Review and Sphere of Influence program.

BE IT FURTHER RESOLVED that the Commission requests that the Mendocino County Auditor apportion and collect the contributions from the member agencies pursuant to Government Code Section 56381.

A special look at the Sacramento-San Joaquin Delta, the most critical water body in California, begins at the confluence of the Sacramento & American Rivers. Next stop, the Sacramento Regional Wastewater Treatment Plant (SRWTP) project - also known as the EchoWater project, the largest inland wastewater discharger in the western U.S. At a cost of \$2 billion, it is financed by the largest federal loan in the 25-year history of the Clean Water State Revolving Fund (SRF) program.

We will then pass through the 18,000 acre (6500 actively managed) Stone Lakes National Wildlife Reserve, a rich mosaic of habitats that support hundreds of species for both resident and migratory wildlife. We will view habitat of native grasslands, riparian forest, woodland savanna, freshwater lakes, freshwater sloughs, perennial wetlands, seasonal wetlands, and vernal pools.

The Mobile Workshop will wrap-up with a lunch in the shade of the Delta levees at The Old Sugar Mill (circa 1934). This unique setting showcases the agricultural history and bounty of the Delta. Farm to fork cuisine, local craft shops and wineries all share space in this vintage setting, located only 15 minutes from Downtown.
