RESOLUTION APPROVING/~~DEFYING~~ FORMATION OF

Community Services District

Designated as, Sea Dune Lake

The following resolution is now offered and read:

WHEREAS, a petition for formation of a special district to
be known as Sea Dune Lake Water District
was duly filed with the Mendocino County

Local Agency Formation Commission, together with supporting documents
required by the rules of said Commission on 1/30/69;

and

WHEREAS, said petition has been processed pursuant to the provisions
of Chapter 6.6 of Part 1, Division 2, Title 5 of the Government Code of
the State of California; and

WHEREAS, at the times and in the form and manner provided by law,
said Executive Officer has given notice of public hearing by this
Commission upon said petition; and

WHEREAS, said Executive Officer has reviewed said petition and
prepared a report, including his recommendations thereon, said petition
and report having been presented to and considered by this Commission;
and

WHEREAS, the public hearing by this Commission was held upon the
date and at the time and place specified in said Notice of Public
hearing and in any subsequent hearings; and

WHEREAS, at such hearing this Commission heard and received all
oral and written protests, objections and evidence which were made,
presented, or filed, and all persons present were given the opportunity
to hear and be heard in respect to any matter relating to said petition
and report.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED that the formation of a
Sea Dune Lake Community
special district be known as Services District being identified in

the files of the Mendocino County Local Agency Formation Commission as
File No. 3, designated as Sea Dune Lake Community Services District,
be and the same is hereby approved by the Mendocino
(approved/denied)
County Local Agency Formation Commission, subject to the following
conditions and terms:

Proponents amend their proposal to Community Services District

- 1) That the request for a water district formation be approved as formation of the Sea Dune Lake Community Services District.
- 2) That the Sea Dune Lake Community Services District be governed by the Board of Supervisors.
- 3) That such district be empowered to perform the activities as enumerated in Government Code Section 61,600 - a through 1.
- 4) That the recording data be shown as Map in Map Case 2, Drawer 5, Page 29 Mendocino County Records.

BE IT FURTHER RESOLVED AND ORDERED that the Executive Officer of said Commission is hereby authorized and directed to mail certified copies of this resolution in the manner as provided by law.
