5. <u>CONTINUATION of Mendocino County Fire Protection Districts (Part 2, 4 Districts)</u> Municipal Service Review (MSR) (LAFCo File M-2012-06)

Potter Valley Community Services District Redwood Valley-Calpella Fire Protection District Mendocino Fire Protection District Albion-Little River Fire Protection District

George Williamson requested a continuation of the Public Hearing to the June 1, 2015 Regular Commission Meeting, which the Commission accepted. Comments and questions were offered by Commissioners Shoemaker, Brown, Hamburg, and McCowen.

Commissioner Shoemaker suggested the Executive Committee meet to discuss the MSR completion schedule. Commissioner McCowen suggested no further reimbursement to Mr. Baracco be made until such time as the work is completed.

Upon motion by Commissioner Hamburg and second by Commissioner McCowen, the Continuation of the Mendocino County Fire Protection District (Part 2, 4 Districts), was approved by roll call vote:

6. Public Hearing for Budget, FY 2015-16

George Williamson presented the Proposed FY 2015-16 Budget in accordance with Mendocino LAFCo Policies and Procedures Chapter III, Section N. The Executive Committee met and reviewed Commission comments and suggestions from April for the final draft which is presented with the final budget hearing and adoption expected in June 2015. Relevant policies will be drafted for the Policies and Procedures revision, as appropriate. Comments and questions were offered by Commissioners Shoemaker, Rosenberg, McCowen, Hammerstrom, Silver, Madrigal, and Mr. Williamson.

Upon motion by Commissioner Hammerstrom and second by Commissioner McCowen, the Commissioner Mileage Reimbursement in the claims packet was approved by roll call vote:

Commissioners Rosenberg and McCowen asked for clarification on Account 7000 "FY 2013-14." Mr. Williamson noted it will be reflected in both the FY 2014-15 Budget Revision and the Final FY 2015-16 Budget presented at the June 1, 2015 Regular Commission Meeting.

Extensive discussion was held regarding the following areas:

- Setting of Special District, City and County contributions (Account 4000)
- Commissioner stipends and travel reimbursement (Account 6740)
- Special District Training Support (Account 9000)

A motion was made by Commissioner McCowen and seconded by Commissioner Rosenberg to approve the Proposed FY 2015/16 Budget with the following changes:

- Account 4000 adjusted to \$120,000
- Use of Residual Cash reduced to \$27,500
- Proposed budget be distributed to the member agencies with notification of the Public Hearing to be held June 1, 2015

A revision to the motion was made by Commissioner McCowen and seconded Commissioner Rosenberg to make the following changes:

- Allocation of \$3,000 to Account 6400 A-87 Costs
- Account 4000 adjusted to \$123,000
- Use of Residual Cash adjusted accordingly
- Proposed budget be distributed to the member agencies with notification of the Public Hearing to be held June 1, 2015
