RESOLUTION NO. 93-3

RESOLUTION OF THE LOCAL AGENCY FORMATION COMMISSION OF MENDOCINO COUNTY DISSOLVING THE NORTH MENDOCINO COUNTY WATER DISTRICT

WHEREAS, it is proposed to dissolve the North Mendocino County Water District pursuant to the Cortese-Knox Local Government Reorganization Act of 1985; and

WHEREAS, this water district has been in existence for at least three years; and

WHEREAS, on information and belief, this water district's corporate powers have not been used during the three year period preceding the date of public notice of this COMMISSION's hearing on this proposed dissolution; and

WHEREAS, on information and belief, during such three-year period there has been the following inactivity: (1) there has been no duly selected and acting quorum of the board of directors, (2) the water district has provided no service of substantial benefit to residents, landowners, or property within the district, (3) the district has not levied and collected taxes, assessments, service charges, or rates for district purposes, and (4) the district has no assets; and

WHEREAS, the COMMISSION held a duly noticed public hearing on the proposed dissolution of this district on May 3, 1993, at which no oral or written protests or objections were presented, and all persons were given the opportunity to speak and be heard with respect to this proposed dissolution and the report thereon of the COMMISSION's Executive Officer;

NOW, THEREFORE, BE IT RESOLVED AND ORDERED:

- 1. THE COMMISSION MAKES THE FOLLOWING FINDINGS:
 - During the above referenced three-year period, there has been no duly selected and acting quorum of the board of directors.
 - (b) During the above referenced three-year period, the district has provided no service of substantial benefit residents, landowners, or property within district.
 - During the above referenced three-year period, district has not levied and collected taxes, assessments, service charges or rates for district purposes.
 - (d) The district has no assets.
 - There is a reasonable probability that the powers of the (e) district will not be used in the future.
- 2. The North Mendocino County Water District is hereby dissolved.
