Formation Commission on September 15, 1976; and,

WHEREAS, said application has been processed pursuant to the provisions  
of Chapter 6.6 of Part 1, Division 2, Title 5 of the Government Code of the State of  
California; and,

WHEREAS, at the times and in the form and manner provided by law, said  
Executive Officer has given notice of public hearing by this Commission upon said  
application; and,

WHEREAS, said Executive Officer has reviewed said application and prepared  
a report, including his recommendations thereon, said application and report having  
being presented to and considered by this Commission; and,

WHEREAS, the public hearing by this Commission was held upon the date  
and the time and the place specified in said Notice of Public Hearing and in any  
subsequent hearings; and,

WHEREAS, this Commission has heard and received all oral and written  
protests, objections and evidence which were made, presented, or filed, and all  
persons were given the opportunity to hear and be heard in respect to any matter

relating to said application and report.


1. Without need for Government Code Section 54797.1
2. Area to be withdrawn from Ukiah Valley Fire Protection District


BE IT FURTHER RESOLVED that the Executive Officer of said Commission is hereby authorized and directed to mail copies of this resolution in the manner as provided by law.


