heard in respect to any matter relating to said petition and report.


NOW, THEREFORE, BE IT RESOLVED AND ORDERED that the annexation of

PUBLIC HEARING

NOTICE IS HEREBY given that a Public Hearing will be held by the Local Agency Formation Commission on the proposed Annexation of the City of Fort Bragg, California, description of property as follows:

(1) 8.97 acres lying to the South of the City of Fort Bragg Flat bordering on and lying Easterly of the State Highway No. 1, and bounded by South St. on the South boundary;

(2) 39.01 acres lying South of the Noyo River, bordering on and lying Easterly of State Highway No. 1, and on the South bordering on State Highway No. 20. The property slopes in an Easterly direction down to the southwest side of the Noyo River.

(3) 48.41 acres, to the South of the City of Fort Bragg. Approximately six acres of flat river frontage; approximately six acres hillside; approximately 36.41 acres flat open property, lying Easterly of State Highway No. 1 and Westerly of Noyo River, bound on the South by South Street.

(4) 1.45 acres. Flat property bordering State Highway No. 1 on the West, and Pudding Creek Road on the South, North of the City of Fort Bragg.
