

RESOLUTION NO. 65-2

RESOLUTION OF THE LOCAL AGENCY FORMATION COMMISSION OF  
THE COUNTY OF MENDOCINO MAKING DETERMINATIONS AND APPROV-  
ING THE PROPOSED ANNEXATION OF TERRITORY DESIGNATED AS  
ROBERT SIMONSON ANNEXATION NO. 65-4 TO THE CITY OF WILLITS

WHEREAS, a mandatory petition for the proposed annexation of certain territory to the City of Willits, in the County of Mendocino was heretofore filed with the Executive Officer of this Local Agency Formation Commission, and said Executive Officer has examined said petition and executed his certificate determining and certifying that said petition is sufficient as a mandatory petition; and

WHEREAS, at the times and in the form and manner provided by law, said Executive Officer has given notice of public hearing by this Commission upon said petition; and

WHEREAS, said Executive Officer has reviewed said petition and prepared a report, including his recommendations, thereon, said petition and report having been presented to and considered by this Commission; and

WHEREAS, the public hearing by this Commission was held upon the date and at the time and place specified in said notice of public hearing and in any order or orders continuing such hearing; and

WHEREAS, at such hearing this Commission heard and received all oral and written protests, objections and evidence which were made, presented or filed, received evidence as to whether the territory proposed to be annexed is inhabited or uninhabited, and all persons present were given an opportunity to hear and be heard in respect to any matter relating to said petition and report,

NOW, THEREFORE, the Local Agency Formation Commission of the County of Mendocino DOES HEREBY RESOLVE, DETERMINE AND ORDER as follows:

Section 1. Subject to the terms and conditions hereinafter specified, said petition is approved.

Section 2. The boundaries, as set forth in the petition, of the territory proposed to be annexed are approved, said territory is found to be uninhabited and said territory is assigned the following distinctive short form designation:

"Robert Simonson Annexation No. 65-4"

Section 3. The Executive Officer is hereby authorized and directed to mail certified copies of this resolution in the manner and as provided in Section 56272 of the Government Code. In addition, said Executive Officer shall also mail to said conducting district a certified copy, without signatures, of said petition.

The above and foregoing Resolution was introduced by Commissioner Vaughn, who moved for its adoption, seconded by Commissioner Mayfield and passed and adopted this 6th day of December, 1965, by the following vote of the Commission:
