RESOLUTION OF THE MENDOCINO COUNTY LOCAL AGENCY FORMATION COMMISSION OPPOSING SENATE BILL 88

WHEREAS, Senate Bill 88 has been introduced for California Legislature providing for prohibiting resort improvement districts from engaging in any activity or providing any service not already engaged in or provided, or budgeted for, as of July 1, 1970; and,

WHEREAS, Mendocino County has a resort improvement district; and,

WHEREAS, the philosophy has been to utilize such districts to the maximum of their capability in the past rather than creating other single purpose districts to provide such services; and,

WHEREAS, Senate Bill 88 would change this basic philosophy and create additional duplication of governmental services.
