RESOLUTION OF THE MENDOCINO COUNTY LOCAL AGENCY FORMATION COMMISSION MAKING DETERMINATIONS AND APPROVING THE

Negative Declaration and Hay Annexation

WHEREAS, a proposal for the proposed annexation of certain territory to the City of Point Arena / Print Harena / With the Executive Officer of this Local Agency Formation Commission pursuant to Title 5, Division 3, commencing with Section 56000 of the Government Code; and,

1. The proposal, being identified in the files of the Mendocino County Local Agency Formation Commission as File No_{88-2} be and the same is hereby approved denied subject to the following conditions and terms:

The tax transfer agreement between the City of Point Arena and the County of Mendocino is accepted.

- 3. The territory includes 156 acres, is found to be unknhabited/inhabited, and is assigned the distinctive short form designation: Hay Annexation to the City of Point Arena
- 4. The City/of Point Arena / District Board of Directors is designated as the conducting authority and is hereby authorized to conduct subsequent proceedings in compliance with this resolution.
- 5. The Executive Officer is hereby authorized and directed to mail certified copies of this resolution as provided in Section 56853 of the Government Code.
