WHEREAS, a petition for annexation of territory to the City of
Willits was duly filed with the Mendocino County Local Agency
Formation Commission on August 14, 1972; and

WHEREAS, said petition has been processed pursuant to the provisions
of Chapter 6.6 of Part 1, Division 2, Title 5 of the Government Code of the
State of California; and

WHEREAS, at the times and in the form and manner provided by law, said
Executive Officer has given notice of public hearing by this Commission upon
said petition; and

WHEREAS, said Executive Officer has reviewed said petition and prepared
a report, including his recommendations thereon, said petition and report
having been presented to and considered by this Commission; and

WHEREAS, the public hearing by this Commission was held upon the
date and at the time and place specified in said Notice of Public Hearing
and in any subsequent hearings; and

WHEREAS, at such hearing this Commission heard and received all oral
and written protests, objections and evidence which were made, presented, or
filed, and all persons present were given the opportunity to hear and be heard
in respect to any matter relating to said petition and report.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED That the annexation of
territory to the City of Willits being identified in the files of the

Mendocino County Local Agency Formation Commission as File No. 72-8,
designated as Lynn Annexation to the City of Willits

be and the same is hereby approved by the Mendocino County Local
(approved/denied)
Agency Formation Commission, subject to the following conditions and terms:

1. Subject area be detached from Little Lake Fire District
2. Annexation be allowed without notice and hearing.
