## RESOLUTION OF THE MENDOCINO COUNTY LOCAL AGENCY FORMATION COMMISSION APPROVING/DENYING FORMATION OF

## GREATER WILLITS AMBULANCE DISTRICT

WHEREAS, an application for formation of a special district to be known as Greater Willits Ambulance District was duly filed with the Mendocino County Local Agency Formation Commission, together with supporting documents required by rules of said Commission on January 16, 1990 ; and,

WHEREAS, said application has been processed pursuant to the provisions of Division 3, Title 5 commencing with Section 56000 of the Government Code of the State of California; and,

WHEREAS, at the times and in the form and manner provided by law, said Executive Officer has given notice of public hearing by this Commission upon said application and prepared a report, including his recommendations thereon, said application and report having been presented to and considered by this Commission; and,

WHEREAS, the public hearing by this Commission was held upon  $\underline{\text{February 5}}$  , 1990 as specified in said Notice of Public Hearing and in any subsequent hearings; and,

WHEREAS, at such hearing this Commission heard and received all oral and written protests, objections and evidence which were made, presented, or filed, and all persons present were given the opportunity to hear and be heard in respect to any matter relating to said application and report.

NOW, THEREFORE, BE IT RESOLVED, that the formation of a special district to be known as Greater Willits Ambulance District being identified in the files of the Mendocino County Local Agency Formation Commission as File No. 90-2 be and the same is hereby approved Action by the Mendocino County Local Agency Formation Commission, subject to the following conditions and terms:

Greater Willits Ambulance District Formation, #90-2 Conditions

- 1. The Commission should accept the Negative Declaration as adopted by the City of Willits Resolution #90-3A dated January 12, 1990, and file with the County Clerk.
- 2. The benefit assessment will include all land use classifications that could have cause or need for service provided by the District whose intent is to provide broad based and equitable assessment.
- 3. The Proposition 4 Limit, as established, will be provided to the County Registrar of Voters Office following action of the Conducting Authority.
- 4. LAFCO should approve this formation with the following conditions:
  - A. That the question of formation of the Greater Willits Ambulance District shall be presented to the voters with the following issues to be listed directly on the ballot:
    - a. A special tax approved by 2/3 of the votes cast by voters voting upon such proposition as proposed by the applicants, which tax will be used solely to support operation of the District.
    - b. A negative vote on the assessment tax will constitute a negative vote on the formation.
    - c. The Proposition 4 Revenue Limit shall be determined to be a maximum of \$190,000, to be brought back to the voters in seven (7) years (June 1997) for re-approval or adjustment, and shall be printed on the ballot.
    - d. Election of the Board of Directors
- 5. The Commission Should designate the Mendocino County Board of Supervisors as the conducting authority for further proceedings, in this case, calling for voter election for the formation and associated tax.

BE IT FURTHER RESOLVED AND ORDERED that the Executive Officer of said Commission is hereby authorized and directed to mail copies of this Resolution in the manner as provided by law.
