RESOLUTION OF THE LOCAL AGENCY FORMATION COMMISSION OF MENDOCINO COUNTY OPPOSING SENATE BILL 476

WHEREAS, Senate Bill 476 would add two special district members to Local Agency Formation Commissions; and,

WHEREAS, this Bill also provides for judicial review of LAFCO determinations; and,

WHEREAS, the present operation of Local Agency Formation Commissions has proved to be successful in carrying out the intent of the Legislature to limit the number of taxing agencies within the State of California; and,

WHEREAS, the provision for judicial review will create uncertainty in the application of Local Agency Formation Commission decisions.


