## RESOLUTION ADOPTING SPHERES OF INFLUENCE FOR FIRE DISTRICTS

## IN MENDOCINO COUNTY

WHEREAS, Section 56427 and 54774.1 of the Government Code requires that the Mendocino County Local Agency Formation Commission (LAFCO) adopt and amend Spheres of Influence according to the provisions of the Government Code; and,

WHEREAS, LAFCO has prepared an analysis of the Spheres of Influence of Fire Service Districts within Mendocino County; and,

WHEREAS, based upon said study, a set of maps indicating the boundaries of individual Spheres of Influence for each agency was prepared; and,

WHEREAS, a preliminary environmental assessment was conducted and a Negative Declaration adopted for the Sphere of Influence project; and,

WHEREAS, the Mendocino County LAFCO has conducted the required public hearings, properly noticed, to solicit comments from \*the general public and from affected jurisdictions regarding proper location of said Spheres of Influence.

NOW, THEREFORE, BE IT RESOLVED, that the Mendocino County Local Agency Formation Commission amends the Spheres of Influence for Fire Service Districts, completed in the fall of 1988, and adopts the Sphere of Influence maps prepared by staff and reviewed by all affected district, at the LAFCO meeting of January 5, 1989, on file in the LAFCO Office at 203 1/2 North State Street, except for Elk Water District, Garcia Fire & Rescue District, South Coast Fire District and the Anderson Valley Community Services District.
